

DOCTORAL RESEARCH FELLOWSHIP POLICY

RV UNIVERSITY

1. Introduction

The research fellowship scheme of RV University (RVU), Bengaluru, is open to candidates who are registered in RVU's full time PhD programme and fulfill the eligibility criteria outlined below.

2. Objectives

The objective of the research fellowship scheme is to enable students who are registered in RVU's full time PhD programme to produce high quality research, leading to the award of a PhD degree.

3. Eligibility

The eligibility criteria are as follows:

- (A) The candidate must be registered in RVU's full time PhD programme.
- (B) The candidate must not be the recipient of any other fellowship from sources including, but not limited to, the UGC, the Indian Council of Historical Research (ICHR), Indian Council of Social Science Research (ICSSR), etc.
- (C) The candidate must not be in employment.

4. Tenure of Fellowship

The tenure of the fellowship is initially for two years starting from the date of registration at the University. Upon expiry of this period, the Research Fellow is required to submit a Progress Report, as per the proforma specified in Annexure 2. An Internal Committee will review the Research Fellow's Progress Report. The Committee will submit an assessment report as per the proforma prescribed in Annexure 3.

If the research work is found satisfactory, the tenure of the fellowship will be extended for another two years. If the research work is found unsatisfactory, the stipend will be discontinued.

The total period of the research fellowship will not exceed four years from the date of registration. There is no provision for further extension.

5. Rates of Fellowship

The fellowship amount is INR 31,000 per month for the first two years, and INR 35,000 per month for the remainder of the tenure.

6. Procedure for release of grants

A. Joining: On receipt of the Joining Report in the prescribed proforma (Annexure- I) and supporting documents, RVU will accept the candidature of the Fellow and will release the first installment of admissible grants as per norms.

B. Progress Report: The Fellow is required to submit a progress report as per the proforma prescribed in Annexure II, at the end of two years from the date of commencement of the fellowship award.

D. Assessment Report: At the end of two years, an Internal Committee will review the Research Fellow's Progress and take an appropriate decision to renew/ discontinue the Fellowship. The Committee will submit an assessment report as per the proforma prescribed in Annexure III. If the Research Fellow's progress is found satisfactory, she / he / they will be eligible to draw the fellowship for the next two years, with periodic annual evaluations thereafter.

7. Housing

In addition to the fellowship, rent-free hostel accommodation in RVU will be provided to candidates, if required.

8. Leave Policy

- A. Research Fellows are entitled to a maximum period of 30 days of leave in a year in addition to public holidays. They are not entitled to any other vacations.
- B. Research Fellows are eligible for maternity/ paternity leave as per Government of India norms issued from time to time, at full rates of fellowship. They may avail of maternity / paternity leave once during the tenure of their award.
- C. Besides this, an 'Intermittent Break' for a maximum period of six months may also be permissible to women candidates. The leave can be availed 3 times during the entire period of fellowship. However, the total duration of leave shall not exceed six months. This Flexi Time period shall **not** be counted towards the tenure of the fellowship and thus, effectively, the total period of fellowship will remain the same, i.e. 4 years from the date of Ph.D. registration.
- D. Academic Leave: Academic leave without fellowship shall be permissible only for one year throughout the tenure (for any kind of academic assignment/ teaching/ foreign visit in connection with research work). The period of leave without fellowship will be counted towards the tenure of fellowship. Thus, effectively, the total period of fellowship will remain the same, i.e. 4 years from the date of Ph.D. registration. Expenditure on foreign visits in connection to research work cannot be claimed from RVU.

Note: All kinds of leave should be approved at the level of the University. Prior approval of the University is mandatory for all types of leaves.

9. Paid Assignment / Job:

The Fellow shall not undertake any paid assignment during the tenure of the fellowship (Except in case of leave without fellowship for up to one academic year during the entire tenure).

10. Other Conditions

The Fellow, with the consent of the guide/head of department, will be required to assist the University in its academic and administrative work, including tutorials, evaluation of the test papers, laboratory demonstration, supervision of fieldwork, library activities like group seminars and symposia, provided such work is not likely to hinder the research project on hand. The total amount of time to be spent on such activities shall not exceed ten hours a week.

11. Cancellation Of Award

The fellowship is liable to cancellation in case of:

- A. Misconduct
- B. Unsatisfactory progress of research work/ failure in any examination related to Ph.D.
- C. He/ She/ They is/ are found ineligible later.
- D. Any false information furnished by the applicant or any fraudulent activity by the research awardee shall lead to penal action against him/ her/ them.
- E. Transfer to other institution.

12. Resignation from the Fellowship:

The Research Fellow may resign from the Fellowship, if she/ he/ they are unable to continue their research work at the University for medical or personal reasons.
