emphasised that policies crucial to agricultural growth are overlooked in both the current and past budgets He clarified that the government provides meagre raises to the budget allocation.





Ministry of Education gets 13% of the budget for: Samagra Shiksha (improve school effectiveness) PM POSHAN (mid-day meal scheme)

Nearly 35% of the gender budget is allocated to the Ministry of Rural Development for: Mahatma Gandhi Rural Employment Guarantee Scheme (100 days guaranteed wage employment) PM Awas Yojana (rural) (affordable housing) National Rural Livelihood Mission Ministry of Drinking Water and Sanitation and Ministry of Health and Family Welfare each get 11-12% of the budget.

Ministry of Housing and Urban Affairs gets 8.5% of the budget for PM Awas Yojana (Urban) (affordable housing)

Ministry of Women and Child Development gets 6.6% of the gender budget.

Corporate Tax of 22% for existing domestic companies and 15% for certain new manufacturing companies.
