Five year Integrated programmes

- B.A. LL.B. (Hons.)
- B.B.A. LL.B. (Hons.)

Four year programme

B.Sc. (Hons.) (Criminology, Cyber Law and Forensic Sciences)

Eligibility and Selection criteria:

- 10+2 or equivalent with minimum 45% marks in aggregate from a recognized board.
- A student who has scored 70% or above is eligible for direct admission. For others, admission will be based on Statement of Purpose (SoP) and personal interview.
- Students who have qualified in CLAT/ LSAT/ CUET examination can apply with their score.

Age limit:

- · For General category: 20 years
- · For SC/ST & Other Backward Communities: 22 years

Course structure:

The course structure will follow what has been prescribed by the Bar Council of India (BCI).

- B.A. LL. B. (Hons.) students will study Economics, Sociology, History, Philosophy or Political Science as additional subjects, besides the Law Courses mandated by BCI.
- B.B.A. LL. B. (Hons.) students will study Management, Accountancy, and Finance, besides the Law Courses mandated by BCI.
